The attached bid tabulation for the Water System was presented to the Commission. Director, Field Services explained the project to the Commission noting the project will allow the water system to be controlled and communicated with remotely. Staff recommended awarding the bid to the evaluated low bidder Killmer Electric Company, Inc. in the amount of \$535,000.00. After discussion, Commissioner Kottke moved to award the bid to Killmer Electric Company, Inc. in the amount of \$535,000.00. Commissioner Simon seconded the motion. All Commissioners voting Aye, the motion passed.

### **Contributed Services**

The Contributed Services report as of April 30, 2016 was presented to the Commission. The Commission signed the report.

#### **Operations/Scorecard**

Staff updated the Commission on changes to the April Scorecard.

#### **General Manager/Staff Report**

General Manager Fritsch updated the Commission on the changes being proposed to the Southern Minnesota Municipal Power Agency (SMMPA) agreement and noted the SMMPA Board is coming close to having a consensus on the outstanding items. He noted the three items that are still being discussed include whether the Agency should include Project Members, whether it should retain the three permanent board seats; and whether the voting should be weighted based on the size of the member.

General Manager Fritsch reported OPU will be receiving an award from the Finance and Commerce magazine as one of the top 100 projects in the State of Minnesota in 2015. The top 12 projects will receive an award.

Director, Field Services Warehime reported a representative from AEGIS, our Excess Liability carrier, was in-house and performed an inspection of our water system processes.

#### **Commission Roundtable**

All Commissioners welcomed Commissioner Rossi to the Board. Commissioner Cosens thanked Commissioner Kottke for his leadership over the past year as Commission President.

#### **Adjournment**

There being no further business to come before the Commission, Commissioner Kottke moved to adjourn the meeting. Commissioner Stansberry seconded the motion. All Commissioners voting Aye, the meeting adjourned at 4:59 p.m.
